**Emergency Called Meeting Concerning the Hickman Lane Bridge**

Mayor Doss "This is an emergency called meeting about the Hickman Lane Bridge it's starting to collapse. We have three bids and we are going to look over the bids. We got R & L Paving total is \$5,548.00, it's got a 90 day guarantee on the work and labor one year. It says on the first page and the third page plus time and material so the \$5,548.00 is not total. So we don't know how much per hour when he says plus time and materials so it looks like we would have to purchase the materials which would be the culvert, gravel, asphalt and whatever else that he would need. The second one is PRI (Pavement Restorations of East TN Inc.) their price is \$10,950.00 from what I can read that covers material and labor it has it itemized down here saw cut and remove asphalt, remove any loose material, form and pour 4000 psi concrete, install asphalt to match it will take two to four working days to complete. It says PRI will not warranty work due to uncertain variables related to existing pipe. So does that mean he is going to use the same pipe?"

Public Works Director Gary Doss "All of them are."

Mayor Doss "All of them are okay. Then the third one is says Rogers Group out of Knoxville its \$15,650.00 placing sand bags around culvert, saw cutting around existing asphalt approx. 7x10, excavating failed asphalt, form work around culvert to prevent concrete from entering creek, placing flow able fill in washed out area, placing 3 inch of E-mix over concrete. Thru a phone call one year warranty on asphalt. Questions?"

Commissioner May "Gary have you looked over there, what all is washing out?"

Public Works Director Doss "Rift raft under there, asphalt is busted in chunks that's all you have under there besides the tile."

Commissioner May "Is the tile still in good shape?"

Public Works Director Doss "From what I can tell they look to me like they are looking back in there with a flashlight."

Commissioner May "So you don't know until you get it tore apart."

Public Works Director Doss "Yes that's about it."

Mayor Doss "I guess those they are ready available to purchase if needed?"

Public Works Director Doss "The tiles?"

Mayor Doss "Yes sir."

Commissioner Beene "Have they said when they can start?"

Public Works Director Doss "I know PRI and R & L can start tomorrow."

Commissioner May "PRI is 2-4 days right?"

Mayor Doss "Yes."

Commissioner Beene "Anybody have any idea how much money we have in our street department for this?"

Mayor Doss "We haven't set the budget so it will have to be appropriated in there thru the fund balance."

A motion to accept bid from PRI (Pavement Restorations of East TN Inc.) in the amount of \$10,950.00 was made by Mayor Doss; 2<sup>nd</sup> by Commissioner May.

Commissioner Beene "I can't vote for doubling the cost of this when we have a local group to do it for \$5,548.00."

Mayor Doss "Well you got hidden cost there on the front page there it says plus time and material and also on the third page."

Commissioner Beene "So this total what they have priced is not the total correct price?"

Mayor Doss "All that is was to accept the job then they are going to add time and material on you from what it says on page one and page three so it may end up being fifteen thousand dollars. Any farther discussion?"

Motion carried 2-1, Commissioner Beene voting No.

Mayor Doss "Gary if you will get ahold of them asap on that."

A motion to adjourn was made by Commissioner Beene; 2<sup>nd</sup> by Mayor Doss. Motion carried 3-0.
