**Communications from Mayor and Commissioners**

Vice Mayor Massengill asked what the policy was for volunteer firefighters who were also city employees and received a call. City Recorder Michelle Horton explained the fire fighter was allowed to go on the call but was expected to call in. A brief discussion followed regarding not having but two fire fighters in the city during the day and the possibility of having city employees EVOC trained to drive the fire truck to a fire allowing firefighters to meet them at the dispatched location. Most times city employees don't know when the fire department has been called out until they see the trucks leave if the city employees agree to take the training they would also need a radio in order to keep up with the calls; since the fire department bi-laws only allow an officer to drive the fire trucks Vice Mayor Massengill will speak with Fire Chief Mike Miles about changing the bi-laws which will allow any EVCO trained firefighter to drive the trucks to a call which will make eliminate this current issue.

## **Old Business**

### **Update on Annex and Water Treatment Plant**

There is a delay on starting the water treatment plant due to weather. The annex project is moving forward; our architect firm Brewer Ingram Fuller Architects Inc. had several questions regarding the roof we are awaiting a reply from SunSet. Once we have all the questions answered we will forward all information to the Clay Copeland for approval. Public Works Director Gary Doss asked "if the outside of the annex building will be painted?" He has to select a color for the water treatment plant and wants to make sure the colors will match. Commissioner Clements would like to see the outside of the annex painted but wants to preserve the historical value of the building and if painting it would make a difference in that she would rather not paint it. Mayor Doss will check with the Historical Society of Rhea County and get their opinion if painting the building would affect the historical value. Vice Mayor Massengill made a motion for Public Works Director Gary Doss to select the color he wanted as long as it was an earth tone color for the brick color on the water treatment plant; 2<sup>nd</sup> by Commissioner Miller. Motion carried 6 – 0.

## **New Business**

### **Any properly presented new business**

Mayor Doss would like the city to join the Dayton Chamber of Commerce; he feels it would be beneficial to the city to be a member of the Chamber. If the city were to join we would need a representative to attend the monthly meetings. A motion was made to become a member of the Dayton Chamber of Commerce by Mayor Doss; 2<sup>nd</sup> by Vice Mayor Massengill. Motion carried 6 – 0. Commissioner Clements will be our representative.

## **Citizen Input**

Mr. Mike Knox asked if the rules regarding mobile home parks had changed. He plans on selling a mobile home and moving in a newer model but wanted to check the current requirements. The only requirement is to comply with the current flood map and get a building permit prior to moving the mobile homes.

A motion to adjourn was made by Commissioner Beene; 2<sup>nd</sup> by Commissioner Clements. Motion carried 6 – 0.
