**Danny Prior – Candidate for school board**

Mayor Doss "Any questions for Mr. Prior? Sir we appreciate you coming down."

Commissioner Beene "Mayor, Do I get my three minutes speech?"

Mayor Doss "Yes sir."

Commissioner Beene "My name is Andy Beene and I'm running for school board to from the ninth district. I just appreciate who ever invited Mr. Danny Prior down so I get my time is as well you know. I want to let everyone know I'm from Rhea County lived here all my life, born right here in Graysville sixty one years ago and hadn't went anywhere. I love my town, my community, my state and school system. I was on the school board for sixteen years and loved every minute of it, been down here at Graysville and yall are probably ready to run me off but I'm still here, been here on city commission off and on for around thirty years, vote me on and vote me off that's fine to as I get a little break every now and then and that's fine too. But I am running for school board, my grandfather was on school board, my father was on school board and I was on school board three generations on the school board and I enjoyed it and still do, serving the city to and if yall except me one more time I'm running again and appreciate all support from here in Graysville. Thank you."

Mayor Doss "Any questions for Andy?"

### **Communications from Mayor and Commissioners**

Commissioner Beene "Carol Ann sent her regards she couldn't be here she is busy but if we need to meet with her she would be glad anytime next week she will be available morning or evening."

Vice Mayor Reel "Well I think we should to go ahead and set that up set up a meeting with her for next week."

Commissioner Beene "She said anytime."

Vice Mayor Reel "Let's try for Monday, is that alright with everybody at whatever time is good for yall."

Commissioner Kaylor "Concerning?"

Vice Mayor Reel "Well there's a lot of things; first of all the agenda each month it seems some of us have no say on what's on there we need to talk about that, the administrative assistant position, along with the city recorder position."

Commissioner Kaylor "Is this going to be an open meeting?"

Vice Mayor Reel "Well it doesn't matter to me however yall won't to do it."

Commissioner Kaylor "Because it's against the law for us to hold private meetings unless it's on litigations towards the city or if there are litigations already in city that's the only thing you can discuss in a private meeting. You cannot tell what you're going to do during the private meeting as far as how you will vote. People have been asking me about it and I got your stuff right here, the last meeting I went to I was told by one commissioner that if you don't vote my way then I'm going to vote to fire which is a strict violation of the sunshine law so I think it needs to be open."

Crowd Applauded

Commissioner Kaylor "And it also goes on to state that if any citizen here has a complaint there is a coalition for the sunshine law they will take it to a circuit court clerk."

Vice Mayor Reel "We also tabled it last month about the city recorders job and that didn't get put on this month agenda."

Commissioner Kaylor "Did you read your packet?"

Vice Mayor Reel "Yes I did."

Commissioner Kaylor "You approved the minutes from last meeting did you not."

Vice Mayor Reel "Yes I did and it also says it was tabled."

Mayor Doss "Lets calm down."

Commissioner Kaylor "I have got the minutes right here and they don't say anything about it being tabled."

Donna Hodge "Who types the minutes?"

Municipal Clerk Amanda Sulcer "I type the minutes."

Mayor Doss "Do you want to have meeting next week?"

Vice Mayor Reel "Yes I do."

Mayor Doss "What day and what hour?"

Vice Mayor Reel "Monday is good for me and we can do it at 4:00, 5:00 it doesn't matter or 9:00 in the morning."

Mayor Doss "I will suggest we get with the attorney and see what her hours will be since Strawberry Festival will be over with, so let's do it under the agreement she is available and then there will be an email sent out. It will be open meeting and will be posted at the regular places."

Vice Mayor Reel "That's fine with me."

Commissioner Beene "We can have an open meeting or we can have a private."

Joy Keylon "Before yall adjourn, I would like to see when you or Michael can come with me to check over the Sam's receipts because I feel like it will be a hostile environment with just me and Michelle there, I would like for either you or Michael to be with me when we look at them Sam's receipts."

Vice Mayor Reel "Well Michaels not working tomorrow."

Commissioner May "I'm going to Chattanooga tomorrow."

Vice Mayor Reel "Well after work tomorrow evening?"

Mrs. Keylon "Yeah will yall be closed then?"

Vice Mayor Reel "It shouldn't be."

City Recorder Horton "Yea, twelve tomorrow."

Commissioner Beene "Are yall closing for the Strawberry Festival?"

City Recorder Horton "Yes."

### **Consent Agenda**

A motion to accept the Consent Agenda was made by Commissioner Kaylor; 2<sup>nd</sup> by Commissioner May.

Commissioner May "On the consent agenda, is there any way we can see it before it goes into the packets?"

Mayor Doss "Probably thru an email."

Commissioner May "So we can't have a meeting before it goes into the packet? The reason I'm asking is I have never seen a light bill and stuff like that and I would like to see it."

City Recorder Michelle Horton "What you get in the packet is all there is for the consent agenda, the monthly reports from each department."

Commissioner May "When does the bill get paid? Is it not thru the consent agenda?"

City Recorder Horton" No."

Commissioner May "No it's not."

City Recorder Horton "Years and years ago the city would vote to pay the bills but they changed that due to so many needing to be paid. I would say it was changed about eight years ago."

Mayor Doss "That also keeps the bills from being late and having to pay a late fee." Anytime you want to come over and look at any of them, like the bank statements you get thru email."

Motion carried 5-0.

Mayor Doss "What's the board's pleasure?"

Vice Mayor Reel "Well I think that's something we discussed with the administrative assistant position. That would be something they would learn as well."

Mayor Doss "So we will hold that then."

### **Surplus of Fire Department ladder truck**

Mayor Doss "Need vehicle inspection form and pictures to get the truck listed on govdeals.com. Do we have it Chief Miles?"

Fire Chief Mike Miles "Who wants them? I got it all filled out and there's the pictures."

City Recorder Horton "I will get it back to you when I'm done."

Susan Miles "I want that back."

Mayor Doss "Yes ma am. Chief while you're up here let's talk about the letter I received Tuesday Night.

Fire Chief Miles "Back in January we had a surprise visit from the ISO, they were in the area doing the county's rating and while they were here they decided to do ours, City of Dayton and Spring City all at the same time. I had a days' notice to get everything together we set down with them with paperwork done and they said they would get back to us in about three months. Last Monday I notified we had went from a five to a four, ten being the worse and one being the best right now we are a four. It should show on peoples insurance on August first. That's good for a town our size."

Crowd Applauded

Mayor Doss "That's real good, thank you sir. Thirty year ago Graysville was a ten; I appreciate everybody in the fire department that has worked towards this for years back it has taken a long time to work towards this."

Fire Chief Miles "I got some of the best members in the county I think who work their butts off to do this, with no pay what so ever. I appreciate them."

Mayor Doss "Dayton is a three now and the county is a five now. I have mentioned it before but I was in an elected official's academy and they used Grayville as an example of a volunteer fire department being a five. We appreciate it, thank you."

Fire Chief Miles "Thank you."

## **New Business**

### **Site Lighting for the new Fire Station**

Dan Brewer "The city has a grant from CBDG and I am the architect for the new fire hall building. In the fire hall there will be an extra truck bay for the Rhea Ambulance service. I'm here tonight to give you an update: we are in the stage of preparing the drawings we are on schedule to finish drawings at end of May and will be submitting them to state agency for approval. Everything is going along fine; I came tonight to ask your input on if the city is in a position to be able to provide any of the site work or utilities work so we can concentrate on the grants funds for building itself? I can move forward as I don't have to have an answer tonight. The building doesn't have to have site lights but it would be nice to have lighting in between the two buildings. "

Mayor Doss "Davis Bacon Rate is it in affect for this grant?"

Mr. Brewer "That's correct."

Mayor Doss "Get us a list of things you think we can do?"

Commissioner Kaylor "This CBDG is it 100% or is it matching the city 80/20?"

Mayor Doss "We got the \$250,000.00 and we had to put up \$145,000.00. We have already secured the money with the pool."

Mr. Brewer "Grand total is about \$400,000.00."

Vice Mayor Reel "Do we have a signed contract with the ambulance service that they are going to rent part of the building?"

Mr. Brewer "We are keeping them up to date as far as accommodating for their vehicle. The mayor may want to take up the negotiation with them to seal that deal."

### **Sanitary Survey**

Mayor Doss "Gary will you tell us about your sanitary survey?"

Public Works Director Doss "It is an annual survey the state does. They come in and spend about a day looking at everything we got, going over paperwork, makes sure our equipment is working properly and rate you on it."

Mayor Doss "In the past what kind of score have you had?"

Public Works Director Doss "Since I been doing it it's ranged in the mid-nineties the last two or three years it's been a 99."

Crowd Applauded

Commissioner Kaylor "Do you know the average for most towns?"

Public Works Director Doss "I really don't know somehow Dayton managed to score a hundred. The state requires you to be above eighty if your below an eighty two years in a row they come in and take over."

Mayor Doss "You worked with the fire department when the ISO cam in also, so it's everybody working together. This board appreciates what you been doing and continue to do for us."

Public Works Director Doss "Thank you."

Mayor Doss "Any comments from the board?"

Commissioner Kaylor "Thank you Gary."

Commissioner Beene "A 99 is real good, everyone in the city should be proud of our water system. Its great the city has a 99 on water and a 4 on the fire, great job."

Commissioner May "Who supposed to paint the fire hydrants?"

Public Works Director Doss "That's a good question. I really don't know."

Mayor Doss "I know who has done it in the past, the fire department has done it in the past."

Mrs. Miles "They are your hydrants they belong to water department."

Public Works Director Doss "I'm not sure how it works, the fire department done it last time."

Commissioner Beene "It would be a good job for the new sanitation workers."

Commissioner May "I think so."



Bobby Baldwin "I would be willing to volunteer my time to go paint them so we could color code them to know what pressure each one is."

Mayor Doss "Get with Gary on that."

### **Payment of Invoices**

Mayor Doss "Need receipts and purchase orders submitted in a timely manner to avoid late fees. I have received several emails since the last meeting about different departments not being speedy on getting it in. I was actually at a business and they brought it up to me about not being paid and that's embarrassing to be out and people hit you up on that."

Commissioner Kaylor "We need to get them turned in, what does it take two minutes to bring them up here?"

Mayor Doss "Or they can just come thru the drive thru."

Commissioner Kaylor "There is no sense in not being able to pay the bills because somebody won't submit their paperwork."

Mayor Doss "If you go to O' Reilly's and get a part, then you just drive thru and give it to Amanda that's where it will end up anyway."

Commissioner Kaylor "Drive thru and drop it off they are around here I don't see any sense in it, it doesn't take three weeks to drive it by the window and drop a bill off to keep from paying a late fee."

Commissioner May "Again I think it needs to fall on the department heads of the department. He/ she needs to be responsible to get those in, you need to step up to the plate, you can't expect an employee to do it as it could end up in a ditch."

Commissioner Kaylor "The department heads need to run their departments, if they can't find someone to replace them."

Mayor Doss "Does each department head issue purchase orders?"

City Recorder Horton "All except for the fire department, Mike will email me and let me know that someone has authority to make a purchase and I email him back with purchase order number."

Mayor Doss "Does Amanda or you know it has been issued out the day they went and got it or do you not know until you get a phone call, any department?"

City Recorder Horton "Any department, no a lot of times I don't know until we get an invoice or call like when you come in about the one business. We had a business come in and check on payment that I knew nothing about it. So it just depends on the company and their ending cycle. There's quite a few we don't know is out there and you guys can see it from the emails, it's becoming an issue."

Commissioner May "I think we need to get a log in place somewhere so a department head can sign that he turns something in, this way we have paperwork saying he turned it in and now we need to find out where it's at. We don't have one right now, but we need something in place."

Commissioner Kaylor "Each department heads know they are supposed to turn them in."

Commissioner May "Well they do know it but it's not happening."

Commissioner Kaylor "It's not happening so start reprimanding or something when they don't turn it."

Commissioner May "That's what I'm saying if we got a log then we can reprimand. If we have something showing this person has done it then we can reprimand."

Mrs. Keylon "How much is the invoice that's in question?"

Commissioner May "Well I don't even know but I'm saying any invoice."

Mrs. Keylon "Well somebody up there knows."

Mayor Doss "Well sometimes they accumulate in one location up to \$1,500.00 all in one month working on a vehicle or whatever."

Mrs. Keylon "It seems like it is just one invoice yall are talking about."

Mayor Doss "Every department at one time has lacked at turning them in. It's just more recent in the last few months that we haven't received all the invoices. We don't need to let it keep happening."

Mrs. Keylon "That I understand I have waited months sometimes years to get paid. I was thinking back to the meeting before Halloween when we were talking about Sam's and Michelle volunteered to get the candy for fire department when she made her trip to Sam's Club. Am I not correct?"

City Recorder Horton "Yes I usually always get their candy."

Mrs. Keylon "Well like I was wondering I stood back there and I could not understand, I know Michelle's comment was sometimes she went twice a month to Sam's to purchase stuff for the city and that sometimes they were eight to nine hundred dollars at Sam's Club. Like I said I run for eleven years and I have been to Sam's club many many times in a month and I could not understand what the city would use from Sam's club in a month or twice a month for eight to nine hundred dollars invoices.

Vice Mayor Reel "Well I would like to see itemized receipts."

Mrs. Keylon "It's printed out at Sam's club when you go it tells you exactly what was bought, I mean the brand name and everything. The reason I was questioning that was because I was at an event in the kitchen or whatever you call the room back there and I seen a lot of things back there that I know come from Sam's club. The way they were packaged and I couldn't understand why there was five and six bottles of mayonnaise in the refrigerator, three or four bottles and I know how it comes like I said you get three packs from Sam's club of mustard. Why three packs of mustard in the refrigerator in the same year, why jars of mixed nuts why was they setting there beside the refrigerator? I checked it all out, there were roman noodles in one package and they come ten to a pack at Sam's club sometimes five to me it looked like the city has been buying somebodies lunch back there. I know when I worked I had to pay for my lunch so I was just wondering and I have asked two or three of the commissioners, I want to see the receipts from Sam's club because I couldn't figure out what the city would buy for that kind of money. Ink pens and copy paper is all I see the city would need, receipt books maybe."

Mayor Doss "Last month Commissioner May had requested to go to Sam's and I don't know if he followed thru with it."

Commissioner May "I did I went with her and she got everything that was on the list. Stuff the library needed and stuff other departments needed."

Mayor Doss "About how much money was spent?"

Commissioner May "Wasn't it around four hundred?"

City Recorder Horton "I believe so."

Mrs. Keylon "Was there mayonnaise?"

Commissioner May "No there was no mayonnaise."

Mrs. Keylon "Roman noodles?"

Commissioner Kaylor "Point of order Mayor."

Court Clerk Michele Yearwood "We buy our own mayonnaise."

Mrs. Keylon "Ten bottles at a time?"

Commissioner Kaylor "Point of order Mayor."

### **Employees clocking in or out**

Mayor Doss "All employees should be clocking in and out not submitting emails listing times worked. Sometime the power goes off and the time clock goes out, but everyone needs to clock in."

Vice Mayor Reel "And that should be on time too."

Mrs. Keylon "Well that was kind of rude of you blocking me off without stopping, like I said I would like to come and see some of those receipt's."

Mayor Doss "You're more than welcome to it's an open book."

Mrs. Keylon "Okay so it is open and you have to go thru Michelle office I guess to get that?"

Mayor Doss "In a timely manner if its convenient for them to go and look it up, if it's something from 2012 then you need to give them time to look it up."

Mrs. Keylon "I would like to see a whole year's worth of them, line for line."

Mayor Doss "Okay that will be fine."

City Recorder Horton "Anything that takes longer than an hour then you would be responsible to pay the employees hourly rate plus cost of copies."

Mrs. Keylon "You're already here so why should I have to pay it for you to look up a receipt for me? I'm already paying you with my taxes. I probably pay more taxes down here then ninety five percent of the people here so I'm paying your salary already. I think anytime I come in you should be able to

get receipt for me for two years ago. I would think something like that would be on a computer, so push and button and there it is."

Commissioner Kaylor "Point of order Mayor."

Mayor Doss "Yeah. Anytime you want to come down."

Mrs. Keylon "Alright I might be here tomorrow, yeah I'll just come on down in the morning. And I'm not bringing my pocket book because I have done paid them. Like I said when I pay taxes I'm paying her for their job, that's what she is here for."

Commissioner Kaylor "Mayor, point of order."

Commissioner May "Employee clocking in and out, say if power goes out it does mess with time clock right?"

City Recorder Horton "You just can't clock in for that time till its reset. I have to get a battery backup on it.

Commissioner May "Was it ever an issue on one of our employees awhile back?"

City Recorder Horton "No it doesn't erase a number or anything like that everyone is still in there and active."

Commissioner May "No not erased, was it ever an issue on one of our employees awhile back?"

City Recorder Horton "We have had a whole day where everybody who comes in at 7:30 am or 8:00 am and it's not reset then they can't clock in it affects all employees not just one or two."

Commissioner May "So then you have to go back in and fix it."

City Recorder Horton "They clock out and then are in for the whole day."

Commissioner May "Another thing on this here payroll you been sending out, I don't know who is doing the payroll here but it seems to me like if you got Potter clocking in at say 7:30 or say 7:00 they start work at what time?"

City Recorder Horton "7:30 am."

Commissioner May "Okay and they are clocking in at 7:00 to 7:15 am it is my understanding if you're on the clock at any given time then we cannot take that time away from you. On some of the time sheets I have been seeing someone has been going thru and high lightening eight hours verses what they have actually worked and I don't think were allowed to do that."

Mayor Doss "What's your recommendation on the employee clocking in?"

Commissioner May "On the employee clocking in?"

Mayor Doss "If they are scheduled to work at 7:30 am, do they stand there till 7:30 am and then clock in?"

Commissioner May "I don't think they should stand there're to wait to clock in but I think at the end of the day or the end of that week if you know you have over time accumulating then you need to work on it. That's where the department heads need to stand up and show authority. You can't just take time from somebody it doesn't need to be adjusted like somebody is adjusting it."

Mayor Doss "Well they get off at four o' clock don't they Gary and they are usually standing there at four o' clock to clock out so if you can get them to clock in closer to 7:30 instead of 7:00."

Public Works Director Doss "How close you want it?"

Mayor Doss "Four or five minutes"

Commissioner May "If you can't do that, you said they leave early due to hot weather on garbage truck right?"

Public Works Director Doss "They usually clock in about twenty after."

Commissioner May "If that's the case have them clock out at 3:45. That way you have the hours in there and you're not having to go back subtract it when you're doing payroll. Do you see what I'm saying?"

City Recorder Horton "Then that's going to be an issue if they come in at seven o' clock and leave at three thirty and someone comes to have water turned on and we aren't there or if Amanda comes in at seven thirty and decides she wants to leave early that's going to open it up for anybody to make their own hours. If you say if you're coming in early we don't want you to get the over time so you can just leave early. So then we won't have any type of schedule."

Commissioner Beene "I thought we had a set time to come in."

City Recorder Horton "We do."

Commissioner Beene "Usually in other businesses they have ten or fifteen minute grace period."

Mrs. Keylon "It's not like if they come at 3:30 to have water turned on your going to be there at 3:35 turning it on."

Commissioner Kaylor "Ten minutes is that what you're saying."

Commissioner May "I understand the grace period and I'm okay with it we just have to do something about their time."

A motion to allow ten minute grace period on clocking in but they do have to clock out on time was made by Commissioner Kaylor; 2<sup>nd</sup> by Mayor Doss. Motion carried 5-0.

### **Parking lot drainage issue**

Commissioner Beene "Mayor I read the email on it has the lady came to look at it?"

City Recorder Horton "She wants to know if you want to meet with her on it, she suggest you guys meet with an engineer. She said she could meet with you if you want to start with her."

Commissioner Beene "We need to start somewhere as I have had citizens complain about how it floods at the end of Long Street when it rains."

Commissioner Kaylor "As far as the parking lot there is a type of pavement that lets water drain down thru it."

City Recorder Horton "She did mention that."

Commissioner Beene "I'm referring to the tile the drain tile itself at the end of Long Street."

### **Resolution 2014-2 Authorization to borrow \$300,000 for the paving of streets and parking lots at the water treatment plant and municipal building**

A motion to accept Resolution 2014-2 Authorization to borrow \$300,000 for the paving of streets and parking lots at the water treatment plant and

municipal building was made by Commissioner Kaylor; 2<sup>nd</sup> by Commissioner Beene. Motion carried 5-0.

### **Hiring Lee Spain as a full time police officer**

Mayor Doss "We got an email from the police department on this subject here, he has been with us more than ninety days at part time but has been working full time probably every week hasn't he chief?"

Police Chief Erik Redden "Correct."

Commissioner Beene "Do you need a motion on that mayor?"

Mayor Doss "Yes sir."

A motion to hire Lee Spain full time and work something out on his back pay was made by Commissioner Beene; 2<sup>nd</sup> by Vice Mayor Reel.

Mayor Doss "Under discussion."

Commissioner Kaylor "Is there any money to pay him? I mean we need to pay him but is there money in there to pay him."

Mayor Doss "The budget workshop we had Monday they were back in the hole as of the last pay period in that line item."

Commissioner Kaylor "There would have to be a budget amendment to pay any of them wouldn't they?"

Mayor Doss "Yes sir."

Commissioner Kaylor "If money is not there you can't just take it from another line item to give it to them. We need to figure out where we can come up with it at. Man needs his money I agree but it can't just say pay him when money is not there. We need to know where it's coming from."

Motion carried 3-2. Commissioner Kaylor and Mayor Doss voting no.

Mayor Doss "It did pass under your motion Andy you were saying back pay; so back pay from when?"

Commissioner Beene "I don't remember the dates just remember reading the email on it. I don't even know how long he has been here, I just know it been more than ninety days so from his ninety days till now."



Police Chief Redden "March 9<sup>th</sup>, it will move him up to \$11.00 a hour from \$9.50."

Mayor Doss "Sounds like we need a workshop or something about amending the budget for police department again."

Commissioner Kaylor "It will have to be amended before the money can come out."

### **Communications from citizens**

Mike Knox "How much balance you have now, I'm talking about general surplus how much do you got on hand now?"

Mayor Doss "It fluctuates so I can't tell you exact."

Mr. Knox "Michelle ought to be able tell you how much you got in the bank."

City Recorder Horton "In both our water and our general fund we have a money market account set aside which is over \$100,000.00 in both of those funds."

Commissioner Beene "We are not broke and we are not raising taxes, so we are in good shape."

Mr. Knox "That's what I'm getting at, we are not broke.
