Mayor Doss told the board of a conversation he and Police Chief Thomas Mahoney had regarding the new stage at the annex. ### **Ordinance 2012-03 Zoning**

The current use of all properties will continue after the adaptation of the zoning ordinance. The city needs to have 2 public meetings and a final passage before the ordinance will take effect. A motion to accept Ordinance 2012-03 Zoning was made by Commissioner Kaylor; 2<sup>nd</sup> by Commissioner Beene. Motion carried 5 – 0.

## **Citizen Input**

Mr. Roger Jaquette is currently on a petition drive to have the alcohol by the drink added to the Graysville ballot in November. The last election both The City of Dayton and The Town of Spring City approved the alcohol by the drink. Mr. Jaquette knows this will bring revenue to our county and will continue working to get this passed for the City of Graysville. He wants to see the county bring jobs and revenue in for those who live here and feels this is an avenue to do that.

Mr. Ray Harvey is having problems with his neighbors and their dogs barking. It sounds like a dog kennel dogs bark around the clock. He is home 95% of the time unable to get out due to his health and all he hears is barking dogs. He also has problems with stray cats running around. Graysville Animal Control will contact the County Animal Control to capture the cats.

Chief Thomas Mahoney presented the board with a contract from B&W regarding photo enforcement cameras. Commissioner Clements asked Chief Mahoney if City Attorney Carol Barron had read over the contract. Chief Mahoney said she had not. The board decided to wait on voting on this issue until City Attorney Ms. Barron could review the contract.
