Brush Collection

Public Works Director Gary Doss was visited by Stephanie Dyer a representative for State of TN Department of Environmental and Conservation Air Pollution Control Division. Ms. Dyer informed Mr. Doss "the city cannot burn brush with leaves on it, must be 200 feet from any dwelling, be manned, and only burn 2 times in a 30 day period. No burning of leaves even for emergencies." Mr. Doss shut down the brush pile, not allowing any brush to be dumped until the city can find a solution. Currently the city isn't picking brush up, we are scheduled to start back in March, we need solution by March.

Animal Control Chain of Command

Police Chief Erik Redden "The animal control ordinance reads it is under police department, for us to be in compliance with ordinance I would like to see it come back to police department." There were issues in the past which have been resolved."
