I would rather have the one from Applied Valve Technologies that way I don't take a chance of voiding any warranty. Thank you."

## **Allegations against Commissioner Charles E Kaylor**

Mayor Doss "Commissioner Kaylor would you like to say anything about this sir?"

Commissioner Kaylor "Sure I would, I have prepared a statement anything after this if you any questions have the attorney's address it. I will answer allegations leveled at me. First it was mentioned my wife knew more about the TBI investigation than members of the board and it was because I told her things, truth is she mentioned nothing not one thing that wasn't already public. It was about the car that was given back to the people it was confiscated from that was already public. Truth is according to Tennessee Code Annotated it is not legal for the person who lost the car to receive it back, by gift, they cannot bid on it at an auction, or buy the car back from the municipality it was awarded to, but yet this board let it go on just a say so: its ok because somebody had talked to someone and they said it's ok. Second, it was said I broke the sunshine law, fact is my wife and I don't set on the same board, it is not against the law for me to talk to my wife. The fact is Mr. Davenport has asked me on numerous occasions my opinion on various things, I have told him countless times according to the sunshine law we can fact find but cannot discuss how we would vote on anything. Fact is Mr. Davenport at times texted my wife to find out different things and at times from early in the morning until late at afternoon he talked to her more than I did. Mr. Davenport stated my wife and I have been in his house and him in ours, fact is I never entered his doors only time we were there was picking his kids up to go to church. It was also stated he was at our house,

when the sunshine law was broken. If this be the case what was he doing at my house, if the law was being broken it is my house. What is the problem he knew where the door was, I'm not leaving my own house because he wants to break the law. If he thought the law was being broken he should have hit the door, it's my house. Third the police report states Mr. Davenport was in his driveway and I waved a gun at him. This is not true. Mr. Davenport and I were friends for a few years; we have never had as much as a crossed word to each other, not the first cross word. Fact is Mr. Davenport quit even talking to me and turned his head on me when the TBI investigations started over thousands of dollars, vehicles and guns missing or mishandled from the police department in which Mr. Davenport was a member of at times, in which I was adamant into getting an investigation started with the TBI. This is when he stopped talking to me but we never a cross word after that we just quit talking. The incident report states he felt concern for the safety of him and his family, but waited four hours and fourteen minutes to report it to his buddy Chief Redden. Now if I felt my family was in danger, I would call 911 immediately as soon as I could get my hands on a phone not the chief but 911, also on the date in question I have witnesses as to my moves all day long and have receipts as to the different places I was on this day. If I was a person to pull a gun I would have when a man that is twice the man Mr. Davenport is when he confronted me and threatened me, but instead I took the legal process and I called 911. Those who know me know I do not promote any kind of violence, but act according to the law. Now as far as the report, this report originated from the police department and was passed out to first this board and then offered to the public to anyone who wanted it. This report had private info such as my social security number on it. This is not legal and I have a copy of it right here it's got my birthdate and social security number on it. This number was also the numbers to access my checking and savings accounts, in which I had to freeze and cannot access until proper documentation is finished. This is a violation to release these numbers. Not being able to access my checking and saving accounts until all documentation is done creates a hardship. Now although you as leaders who received this first as Mr. Davenport handed them to you first may not have known this was not legal you do now. I ask you to act accordingly find the party or parties who released this and act accordingly as if it was your numbers that was released. With these numbers who is to say six months or even later there is not an identity theft? If you choose not to then in the future depending on my attorney you could possibly end up in court. Now due to legal advice because of the possibility of a defamation of charter law suit, the possibility of a theft of identity law suit and other things not mentioned, this is the end of my statement any further questions your attorney needs to contact mine."

Mayor Doss "Any other thing from the board?"
